### Background

The 2025 Shorewood Community Survey provided residents the opportunity to rate the quality of life in the city, as well as the service delivery and overall workings of local government. The survey also gave residents a chance to provide feedback to the City on what is working well and what is not, and share their priorities for community planning and resource allocation. The 2025 Community Survey was made available online April 14 to May 23, 2025. Print copies of the survey were also available. A total of 301 surveys were received. 295 surveys were completed online and 6 surveys in paper form were received.

This is the first general survey of Shorewood residents that the City has conducted since the *2011 Shorewood, MN Citizen Survey*, in which 613 completed surveys were received. To view and compare results of the 2011 survey, visit [shorewoodmn.gov/2011survey](http://shorewoodmn.gov/2011survey). 2025 survey results have been summarized in the attached document.

It is important to note that, unlike past community surveys, the 2025 survey is not a statistical sampling of the community. Although questions were similar or identical to those used in past surveys, the 2025 survey was open and available to anyone to complete.

## **Executive Summary**

## Survey Results

### Quality of Life and Community

The 2025 Shorewood Resident Survey gauged residents’ perspectives about different aspects of quality of life in Shorewood. Respondents also were asked to evaluate a number of characteristics of the community, identify statements that best describe Shorewood and rate how safe they felt in and around the City.

### Aspects of Quality of Life

The overall quality of life in the City was believed to be “excellent” or “good” by nearly all respondents (91%). Percentages shown here and throughout the report body are for those who had an opinion.

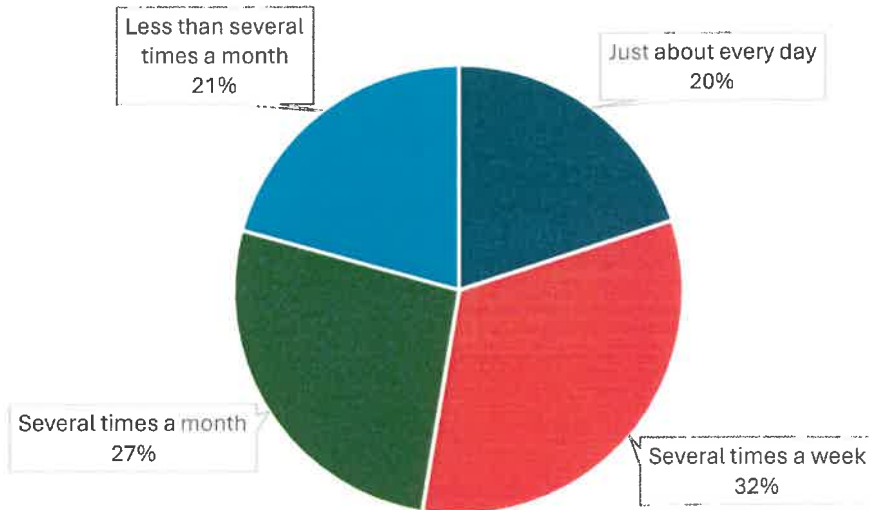

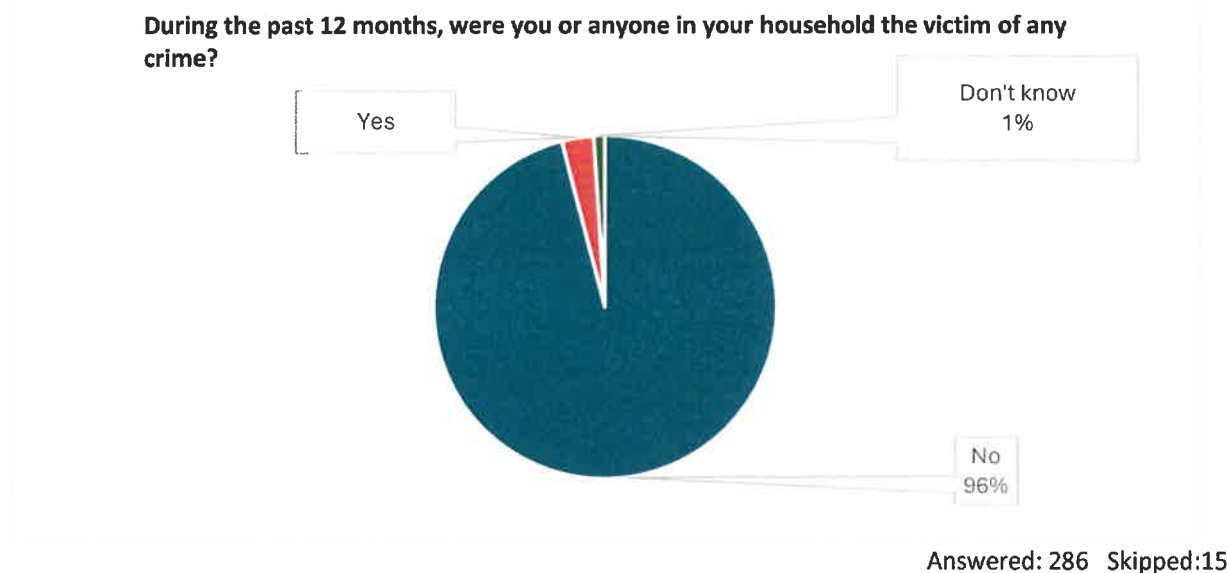

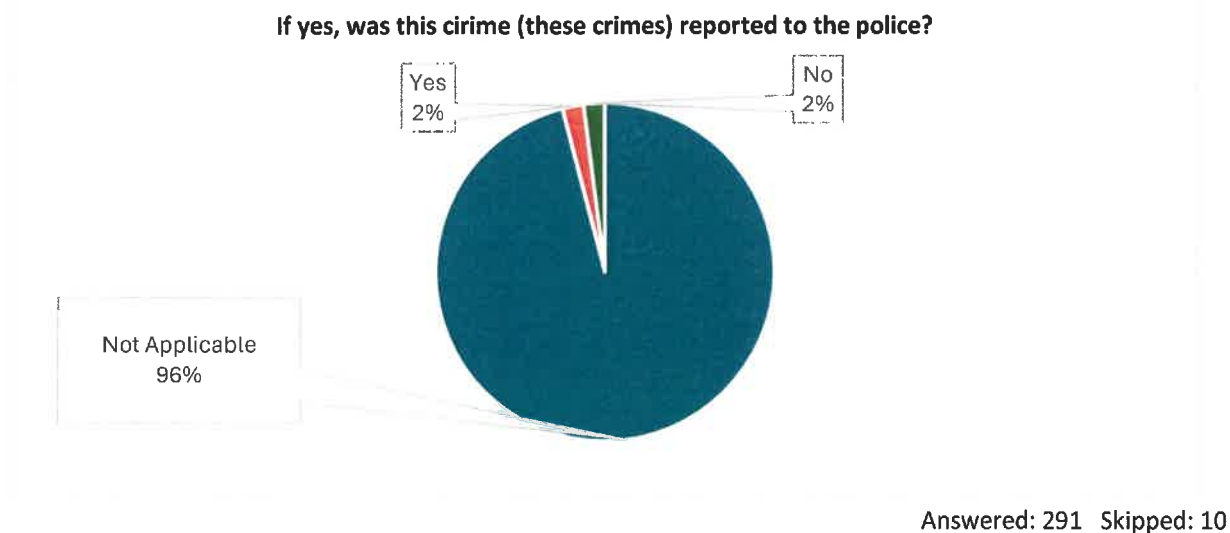
### Safety in Shorewood

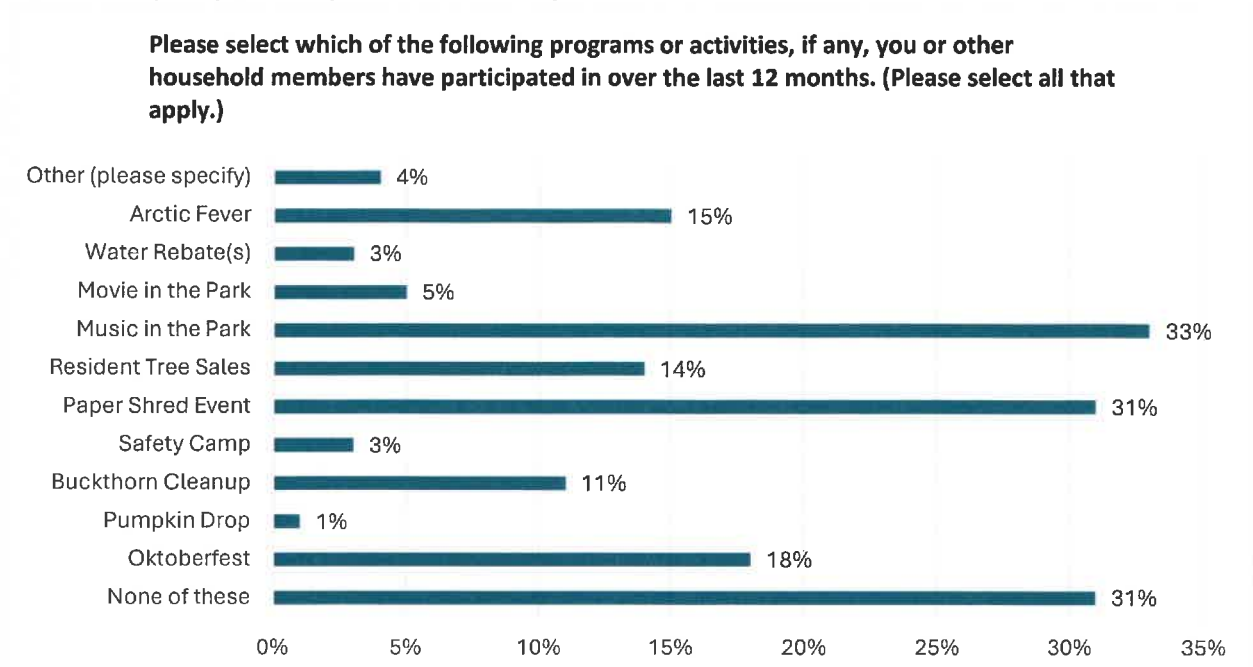

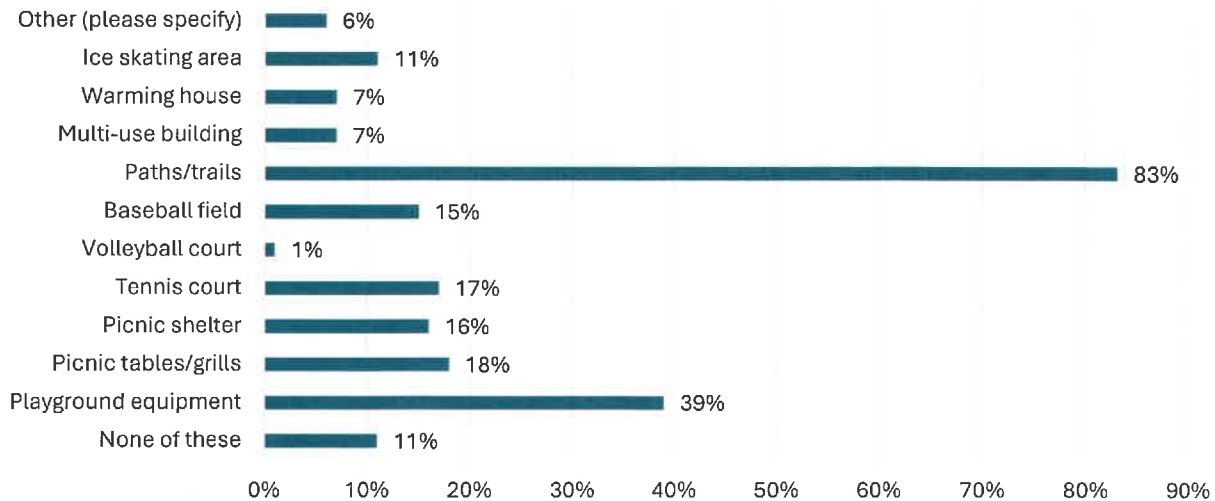

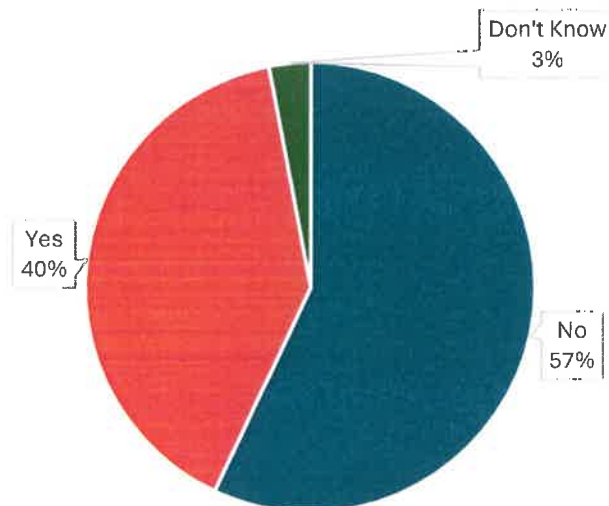

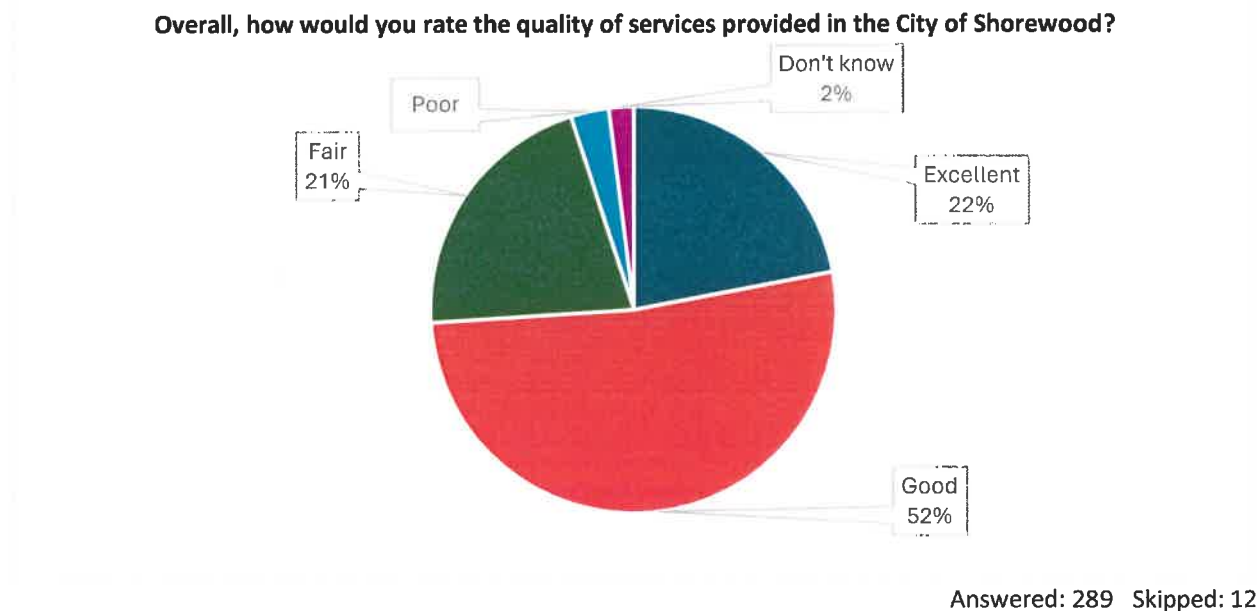

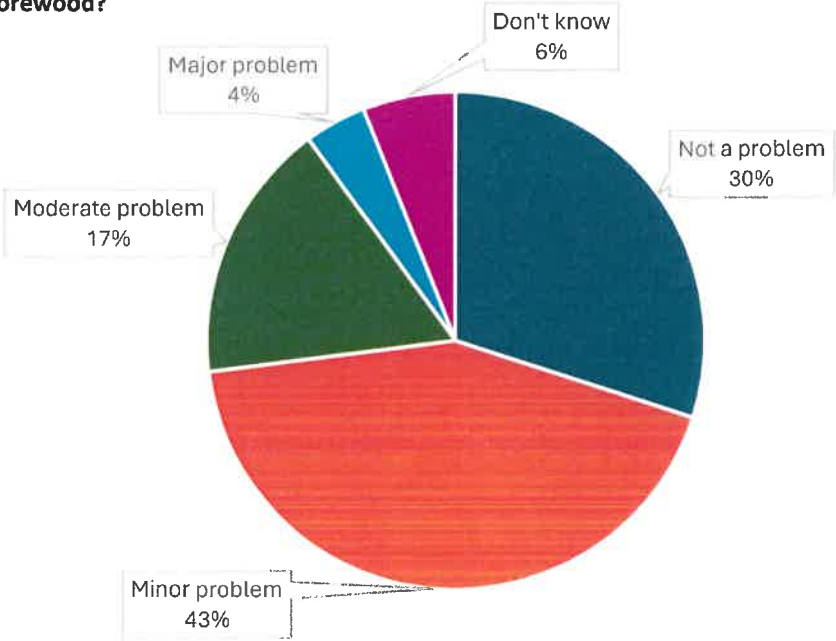

To what degree, if at all, are run-down buildings, weed lots or junk vehicles a problem in Shorewood?

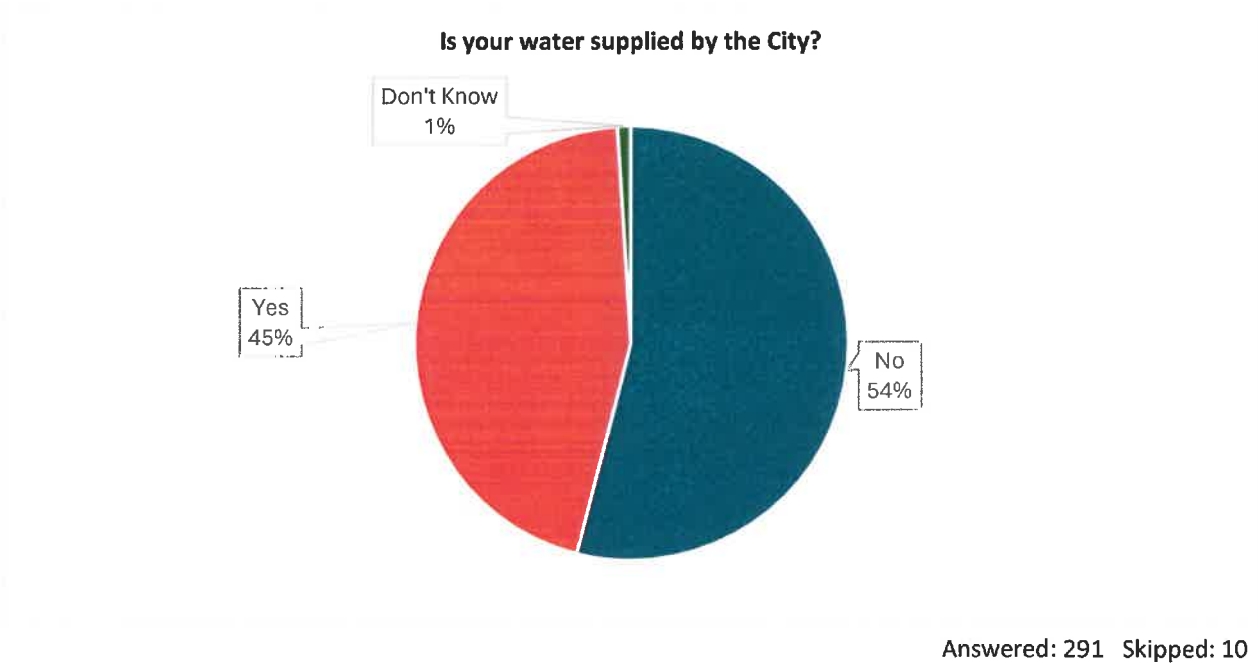

City Water

Ninety-seven percent of total survey respondents reported on whether or not their water is supplied by the City. Forty-four percent of these respondents reported their water is supplied by the City.

Figure 9: Water is Supplied by the City



Those who reported having municipal water service were asked to rate several aspects of the service. Nearly half (48%) believe the quality or taste of water is “excellent” or “good.” Over half (61%) feel the dependability of the service is “excellent” or “good.” A little over one-third (35%) said the cost of City water is “fair” or “poor.”

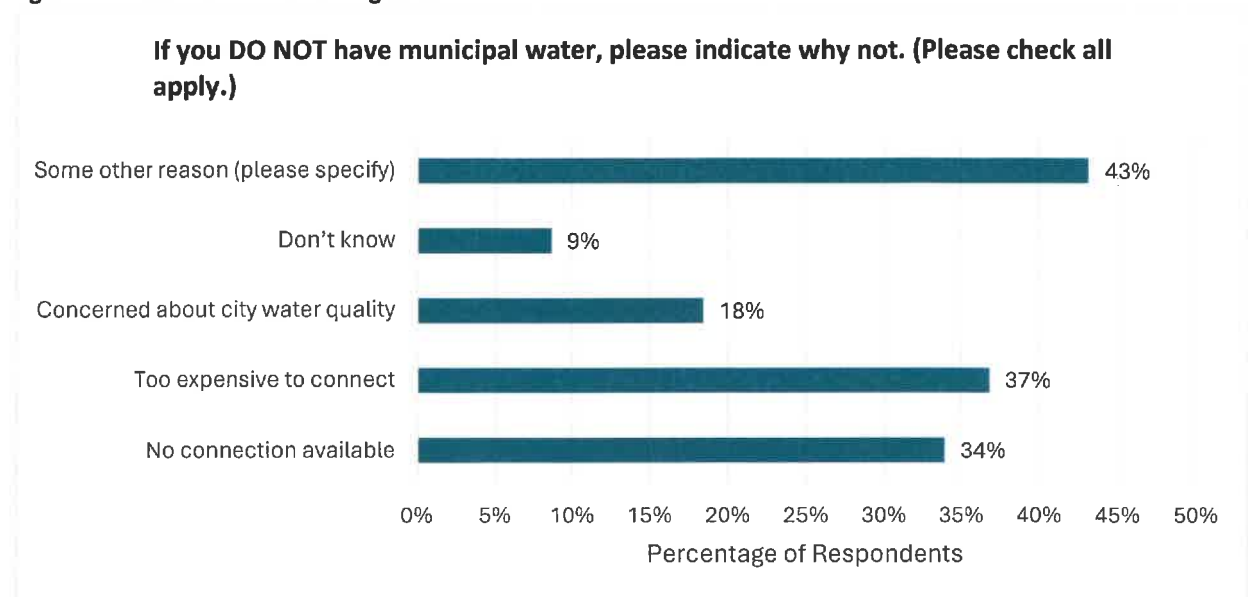

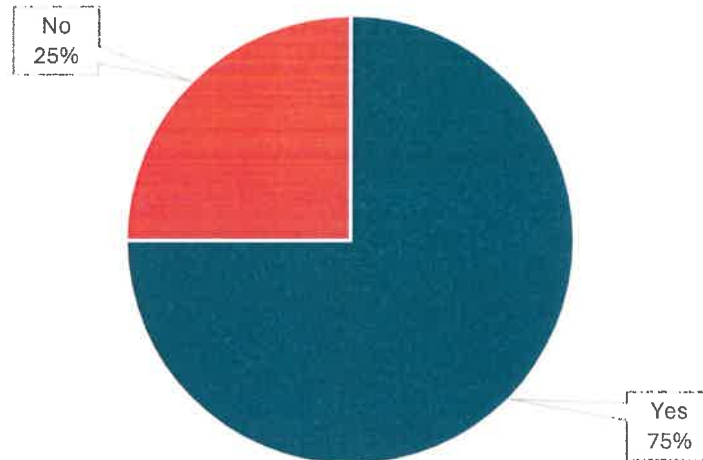

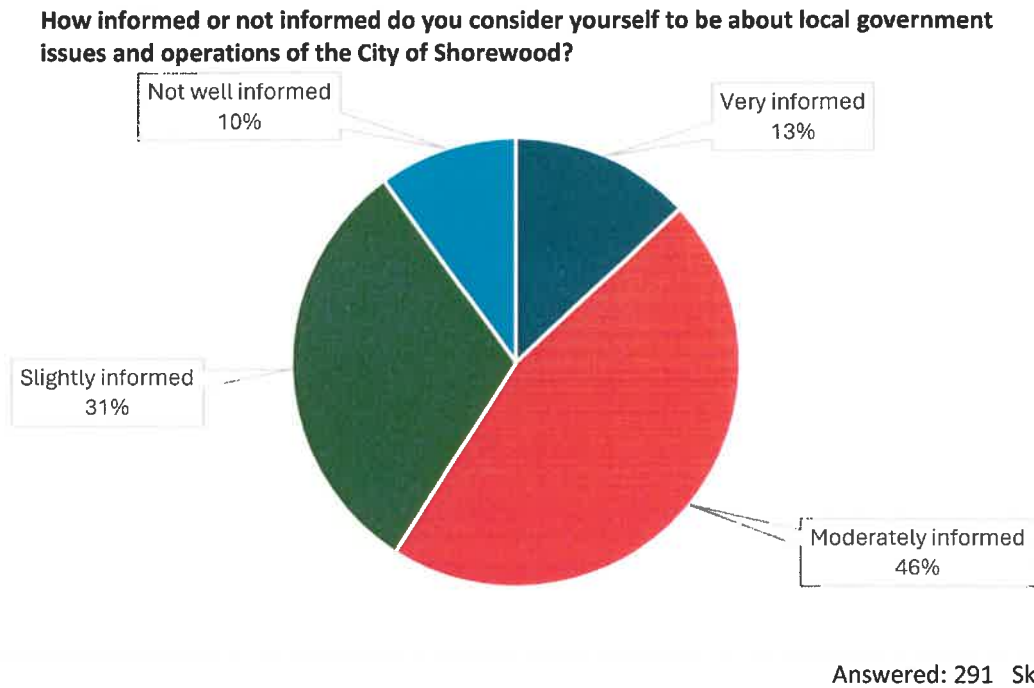

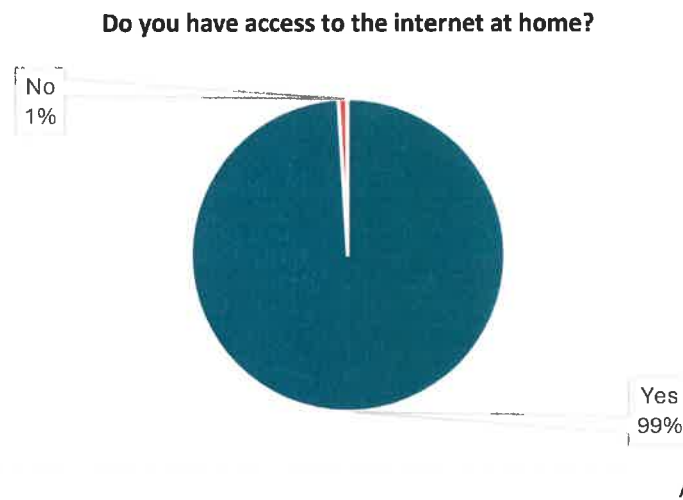

**Figure 12: Level of Awareness about City Issues & Operations**



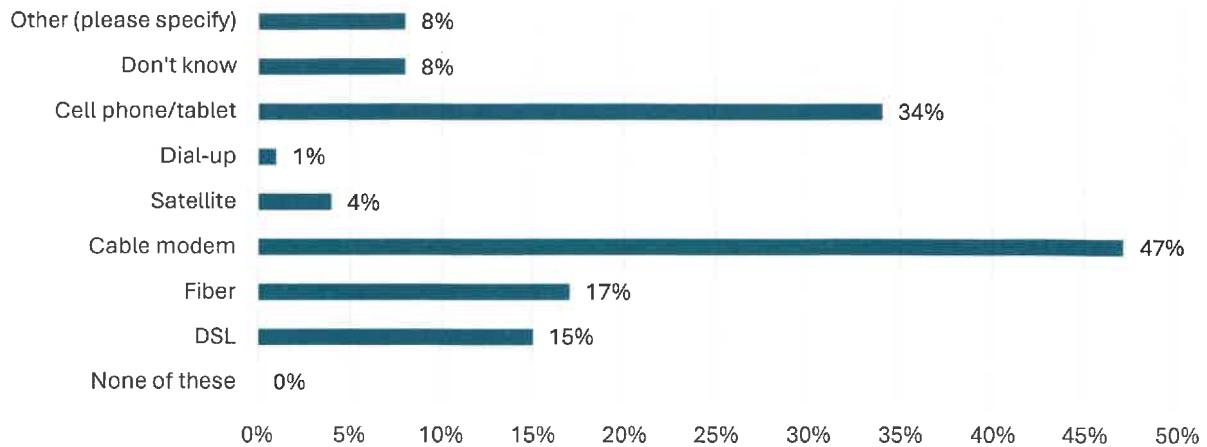

9. All meetings-commissions and council should be Zoom or at minimum recorded for later viewing. Unless someone actually goes to a meeting, esp. any with public hearings, there is about 3-4 week lapse before even the minutes are available. Hard for residents to figure anything out.

10. The question about staff response, etc., An issue with a permit for a fence was never inspected, the fence is in violation, took 3 visits to city hall and on the 4th someone came out. The situation remains unsolved 2 years later.

11. Regarding code violations, the complaint only "plan" sucks. Either a resident narcs on a neighbor and gets "marked" or you live with the mess. Drive around this town, the violations visible from the street are disturbing-not just on private property but on city-owned property!

12. There is a lot of wealth in the city, and a lot of older homes that appear to be just getting by. The common thread among residents is that the wealthy have preferential treatment. True or not, it is the perception.

14. Shorewood has been so focused on saving trees that it has not seen the forest for the trees. As a result we have a high population of ash that will all be dead by the end of next year. Freeman Park is devastated. What is the budget for removal? Please allow residents to have a choice among trash haulers. Thank-you so very much to all individuals involved in starting and keeping up the half-price bakery and the beautiful economical greeting cards at the Shorewood Center. Thank-you too to the volunteers at the desk. It is very much appreciated. Also, a suggestion would be to have a local directory of recommendations for trusted economical services such as handyman repair, yard help, snow removal, etc. That seems better than just having to pick some random anybody out of the junk mail.....Thank-you to everybody who keeps up the roads. It is spectacular how well kept the roads and walkways always are even and especially right after a snowstorm. It is appreciated so much.

If you frequently don't get any neighbor feedback as part of your notification process, then maybe you need to reexamine it. Council often asks about how they didn't hear any feedback. 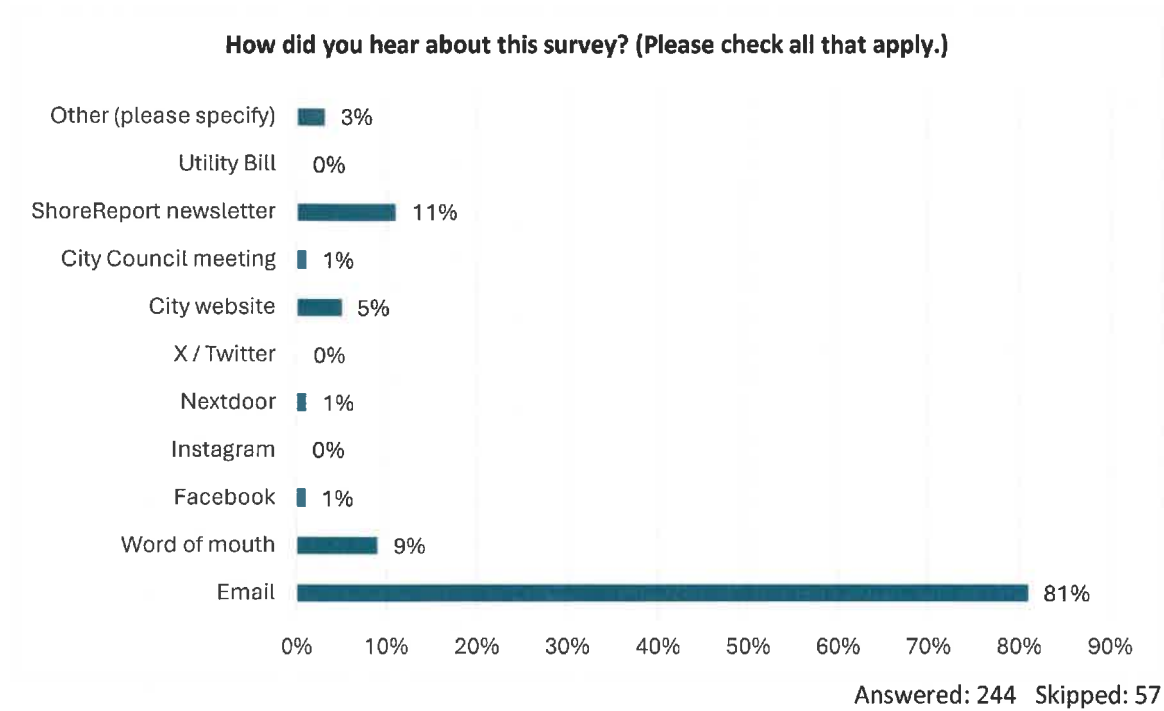

### Background

This meeting kicks off the Council's involvement in the 2026 Budget process. This Goal Setting Work Session has been implemented in response to the City Council's desire to be engaged in the budget process earlier. Last month, Staff started working on their departmental/fund budgets as well as personnel, capital requests, and more. As in years past, there will be a number of budget work sessions over the next several months, during which we will review the various City funds, discuss the proposed property tax levy and tax rate, review tax impacts on properties, update the 10-year Capital Improvement Plan (CIP), update the Fee Schedule, etc.

There are several circumstances that should be factored in as the Council considers the development of the 2026 budget. The current state of the economy (high inflation, rising interest rates, etc. will likely have negative impacts on City revenues (lower) and expenses (higher) as we move through the remainder of 2025 into 2026.

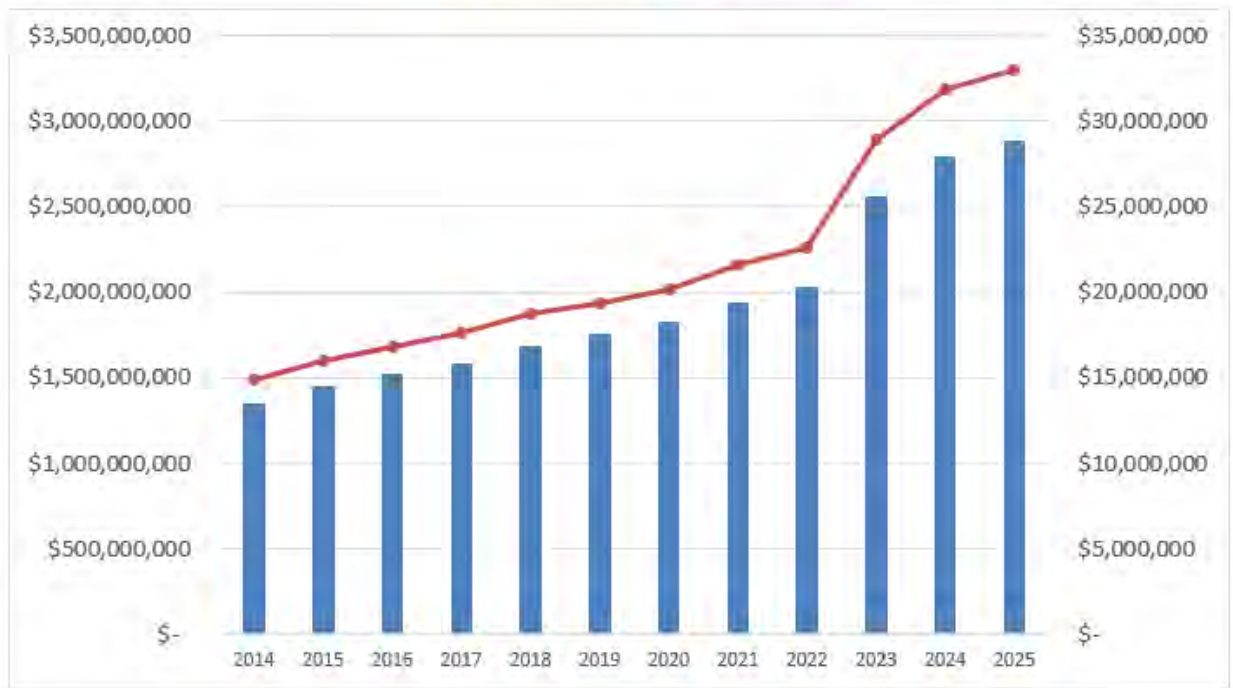
Although there are numerous decisions to be made through the development of the 2026 budget, the two key scheduled actions are the approval of the preliminary budget and levy in September, as well as adopting the 2026 Fee Schedule, and then the adoption of the final 2026 budget and property tax levy in December. Along with these, we will also be finalizing the 2026-2035 CIP, and other budget related actions.

### Financial or Budget Considerations:

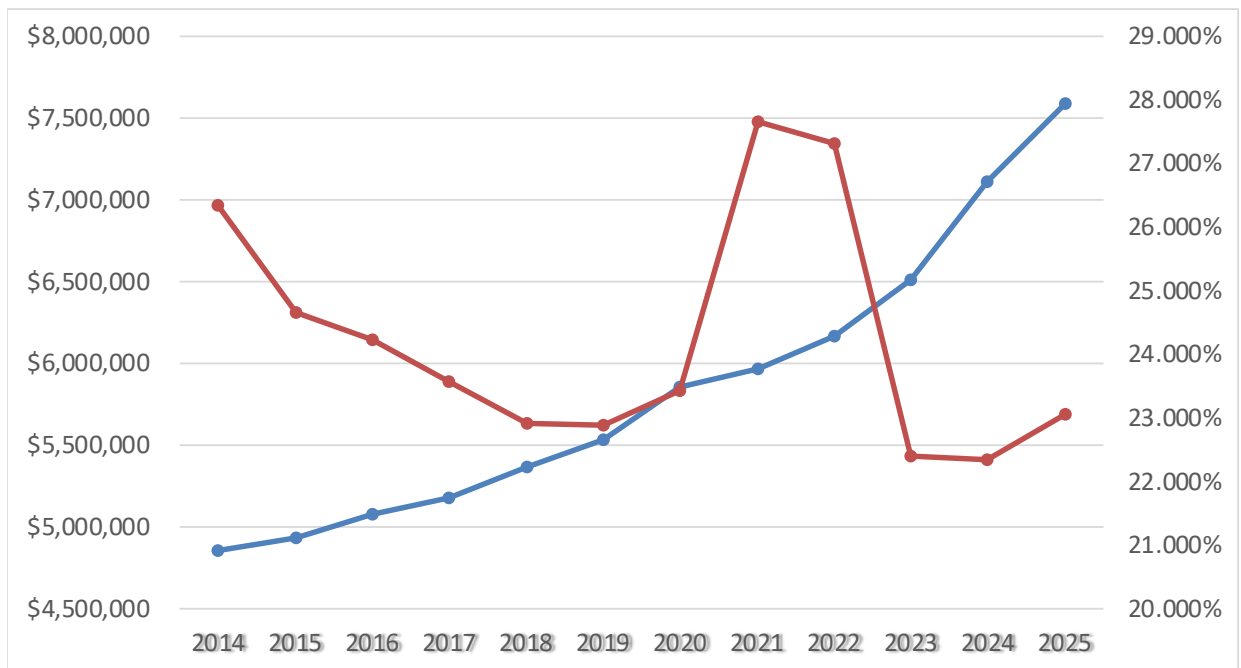

Property Tax Levy / Estimated Tax Rate

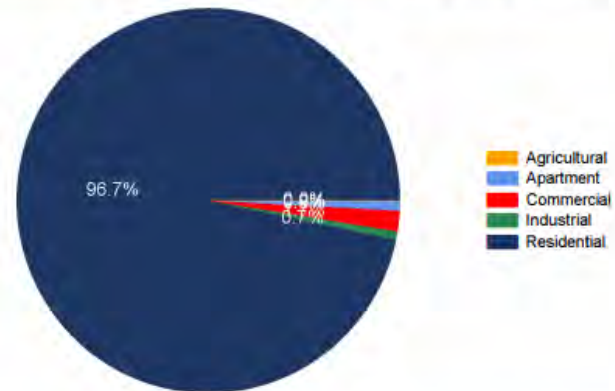

# Impact of real estate values on property assessments

## Property valuations

The state of Minnesota requires the assessor to value properties at their market value, as of January 2 each year. Our purpose is to determine the amount the property would sell for. This means your assessed value may be different than what you paid for your property.

The valuation notice you received in 2024 included the property's estimated market value as of January 2, 2024. We use the 2024 market value to calculate property taxes for the following year, 2025.

## Market Trends

Residential real estate prices have fluctuated the last few years. Property values in some communities keep increasing while the values in other communities are stable to slightly decreasing. Currently, the supply of homes for sale remains well below historic norms.

Commercial, industrial and apartment property prices are affected by a more complex set of factors than residential property.

## How we use mass appraisal

Mass appraisal seeks to value all properties based on the sale of similar properties. So we assess property not on an individual sale but a consideration of many sales.



## Impact on a \$300,000 home

The assessment date is January 2 of each year.

**If the market appreciated, say, 5% in your area:**

 A purchase price of **\$300,000** in January 2023 would indicate a value closer to **\$315,000** as of January 2024.

 A purchase price of **\$307,500** in July 2023 would also indicate a value closer to **\$315,000** as of January 2024.
